




#### Admission Requirements:

- Undergraduate degree: Minimum of a second-class lower university degree or a Higher National Diploma together with a postgraduate diploma from a recognised institution.
- O'Levels: 5 Credit passes, including English and Mathematics
- Entrance Exam: LBS Entrance Exam.
- In-Person Assessment: Interview to evaluate intellectual capacity, professionalism, maturity, and motivation.



#### **Supporting Documents**

Your application should be accompanied by the following documents:

- Letters from two referees (one of whom should know the applicant in an academic capacity)
- Copy of O'Levels Results
- Proof of University Degree
- A recent passport photograph taken within the last six months
- In case of self-sponsorship, please provide three months bank statement



#### Fee:

The application fee is N45,000 (Forty-five thousand naira only).
